1. Call to Order

Chairperson Dixie Wall called the meeting to order at 9:00am. Chairperson Wall reminded the board about the rules of debate.

2. Cleanup legislation update, stakeholder concerns, current proposed language Motion (1): Dixon/Tuck – Move to instruct staff to pursue the proposed amendments to BP 4600 as prepared for today's meeting.

Ms. May stated that the first 14 amendments were already discussed in multiple meetings and she only wanted to present the two new amendments to the Board.

- 1) Amend 4612(c) to hold the certified owner responsible for staff behavior even if not all are certified.
- 2) Amend Sections 4602 to allow for interim suspension after investigation by PSD based on substantial evidence of sexual offenses or felonies in sworn victim declarations.

Mr. Schroeder proposed friendly amendment:

4602(d)(1) Notwithstanding any other provision of law, if the council receives substantial credible evidence that a certificate holder has committed an act punishable as a sexually related crime or a felony, the council may immediately suspend the certificate of that certificate holder. A decision to immediately suspend a certificate pursuant to this subsection shall be based on substantial evidence and the council shall also consider (1) any available credible mitigating evidence; and (2) whether such certificate holder represents a danger to commit further acts punishable as a sexually related crime or a felony before making a decision to suspend. Written statements by any person shall not be considered by the council when determining whether to immediately suspend a certificate unless made under penalty of perjury. If the council suspends the certificate of a certificate holder in accordance with this subsection (d)(1), it shall take all of the following additional actions:

- (A) Notify within ten (10) days, the certificate holder at the address last filed with the council, that the certificate has been suspended and the reason for the suspension.
- (B) Notify within ten (10) days, any business that the council has in its records where the certificate holder practices, that the certificate has been suspended.
- (C) Certificate holders suspended based on section 4602(d)(1) and (d)(2) shall have the right to request a hearing within thirty (30) days after notice of suspension is issued by the council to challenge the factual bases for such suspension.

This would be the entirety of the text of 4602(d)(1). In addition, there would not be a need to amend 4603(a).
