1. Call to Order

Chairperson Wall called the meeting to order at 9:00am.

2. Special Meeting Finding

Counsel England declared this meeting has been called and noticed pursuant to the special meeting provision of the Bagley-Keene Open Meeting Act (Act) which allows for a meeting on less than 10 days notice under certain circumstances, including consideration of proposed legislation. England asked the Board to vote on whether to hold this special meeting.

Motion (1): Fuson/Grant – Based on the immediate need for CAMTC to discuss proposed legislation, including a proposed third party bill that potentially affects all massage professionals, as well as CAMTC's own proposed legislation, we move to hold this special meeting pursuant to the Act on less than 10 days notice because further delay would create a substantial hardship.

3. Pending Legislation – AB1193

Mr. Netanel stated that CAMTC has not taken a formal position on AB 1193. Mr. Netanel stated that CAMTC is in a situation where we will not have the luxury of having at least 10 days to call a Board meeting before a position can be taken and the purpose of this call is to have one or two individuals to take a position on behalf of CAMTC in regard to this Bill if and when it becomes necessary.

Motion (2): Benson/Schroeder – CAMTC supports the general intent of AB 1193 to authorize the CEO and his designees to seek exception as per provisions in the Business and Professions Code, Section 4612 for CAMTC certified sole proprietors and massage business establishments who employ CAMTC certified massage professionals.

Schroeder – Friendly Amendment – Add to the motion to oppose the bill if the amendments are not accepted.

Benson accepts Friendly Amendment.

Netanel – Friendly Amendment – To replace the word "employs" with the word "use".

Benson accepts Friendly Amendment

Mr. Netanel recommends the Board add to the motion to authorize the Chair and CEO to decide the timing as to when to make the position official.

Benson/Schroeder accepts Friendly Amendment.

Motion (2) is as follows:

CAMTC supports the general intent of AB 1193 but oppose the bill unless amended to exempt CAMTC certified sole proprietors and massage business establishments that only use CAMTC certified massage professionals. CAMTC authorized Chair and CEO to decide the timing as to when to make the position official.
